



Memorandum of Understanding

Between

Kut University College / Republic of Iraq

Shree Chanakya Education Society's, Indira Group of Institutes, Pune / Republic of India

Due to the important of education as an element of comprehensive development and as an important pillar of building the modern society, and according to the will of the Kut University College / Republic of Iraq and Shree Chanakya Education Society's, Indira Group of Institutes, Pune / Republic of India referred to later as (parties), to strengthen relationships in the scientific and cultural field, exchange experiences by utilizing the capabilities of the two parties, activate scientific and humanitarian links which serve the progress of humans, and activate the cultural dialogue between civilizations; we have agreed on the following:

Article one

Both parties exchange visits of faculty members in the following fields:

First:

Do joint research for (1-3) months.

Second:

Exchange experiences and lecturing for (1-4) weeks.

Third:

Teaching for one

semester. Fourth:

The provisions of these areas are implemented according to the internal systems of both contracting universities after the written consent of each of their heads.

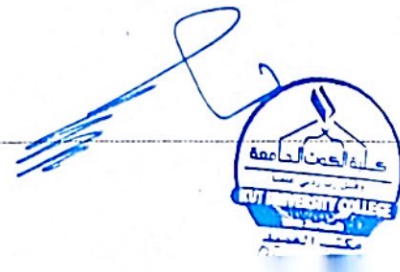
Article two

First:

Each party sends an invitation to the other party to participate in scientific conferences and seminars. The calling party bears all the costs (hosting and sharing) except international travel fares.

Second:

Both universities seek cooperation with scientific research and production institutions for training or planning and introduce them to their students and graduates.





Article three

Both parties exchange visits of faculty, managerial, and technical staff for training or exchanging experiences. Number of participants, specialties, and visit duration are determined by prior correspondence. The sending party bears the costs of two-way travel fees. The hosting party provides secure accommodation and hosting expenses.

Article four

Both parties exchange books, publications, scientific periodicals, and research results in the languages that benefit the two parties. This exchange takes into account the laws of intellectual property protection applicable in both countries.

Article five

Both parties exchange students' delegations in scientific and cultural visits. The sending party bears the costs of two-way travel fees. The hosting party bears the costs accommodation, internal transportation, and daily stipends for (1-4_ weeks, providing that a faculty staff heads the delegate on as a supervisor. Number of students and duration of the visit are decided in prior correspondence between the two parties.

Article six

First:

The executive programs related to the application of this memorandum will be exchanged for specific specializations and activities aimed at developing cooperation between the two universities.

Second:

Every university appoints a coordinator to implement the MOU according to its provisions. Coordinators are assigned by both parties.

Article seven

First:

The nature of each visit and the number of visitors shall be determined by prior correspondence.

Second:

In case of adding any new paragraph or marking any amendment to the texts of this MOU, both parties should agree ahead of time. No amendment or renewal is allowed without a written consent of both parties.

Third:

Any other activities to be agreed upon according to subsequent protocols.





Article Eight

This MOU is considered in action from the time of signing it by the two parties and after the validation of the required entities. This MOU stays in action for three (3) extendable years unless one party notifies the other one (in writing about the intention of closing it six months prior to the actual deadline of the MOU).

Article Nine

All disputes resulted from implementing or interpreting the articles of this MOU are resolved directly by the two parties. If both parties are unable to find a solution, then a coordination committee formed is formed for this purpose. If the committee is unable to find a resolution, then the MOU is ended.

Article Ten

All financial and managerial issues are determined by direct communication between the two parties providing that their detail is identified according to an executive program attached to the text of the MOU as an inseparable part of it.

Article Eleven

Intellectual rights are protected and used by both parties according to their interior laws.

Article Twelve

In case of ending this MOU, both parties agree to continue the activities which have started already finish them.

Article Thirteen

Identify the languages by which the MOU was written and their legal arguments in addition to specifying the determined language for interpreting the items of this MOU.

Article Fourteen

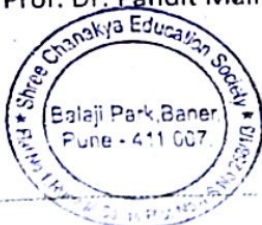
Facilitate the issuance of visas to both parties.
